Minutes of the Meeting of the **Professional Surveying Committee** of the Board held February 6, 2003 in Jett Hall, NMSU, Las Cruces, NM.

1. CONVENE, ROLL CALL AND INTRODUCTION OF GUESTS

Chair Billingsley convened the meeting at 1:10 p.m. A roll call was taken. It was noted that all members were present.

2. <u>APPROVAL OF THE AGENDA</u>

It was moved by Mr. Forstbauer, seconded by Mr. Cala and unanimously, **VOTED:** to approve the agenda as presented with the deletion of 6.1 "Four-year, Board-approved Surveying Curriculum & Four-year Board-approved Related Science Curriculum".

3. <u>APPROVAL OF THE MINUTES</u>

3.1 Minutes of the December 13, 2002 Minutes

It was moved by Mr. Forstbauer seconded by Mr. Cala and unanimously, **VOTED**: To approve the minutes of the December 13, 2002 meeting.

4. **<u>NEW BUSINESS - None</u>**

4.1 **NCEES Professional Activities and Knowledges Survey (PAKS) for Land Surveying** – Mrs. Garcia reported that NCEES was initiating a new PAKS for surveying. It includes the development of a job analysis and survey questionnaire that will be sent to surveyors across the country. She had responded to NCEES with the number of in-state and out-of-state surveyors in New Mexico. NCEES will be requesting a roster of certain surveyors in order to send them a survey.

4.2 **Invitation to Provide Presentation** – Ms. Garcia stated that David Freienmuth, President of the SW Chapter of the Land Surveyors of Colorado had called and inquired if someone from the Board might be able to give a presentation during their Four Corners Area Surveying Seminar 2002. He stated that 30 to 40 NM licensed surveyors attend this function. The seminar is scheduled for June 6-7, 2003. The NM presentation would be on Saturday, June 7th at Fort Lewis College, Durango. It was moved by Mr. Kaufman, seconded by Mr. Cala and unanimously,

VOTED: for Ron Forstbauer to provide this presentation. Ms. Garcia will contact Mr. Freienmuth.

5. <u>COMMUNICATIONS</u>

5.1 John R. Fenn, President, NSPS – RE: Registration Boards Forum – The committee concurred that it would not send a representative to this forum. Mrs. Garcia will notify them.

5.2 Tom Rollag – Photogrammetry and Licensing Act – Mr. Rollag's letter related to the potential inclusion of a "tiered" structure of licensing under the practice of surveying definition to include such functions as geodetic surveying, construction surveying, some GIS activities as well as photogrammetry. It also included a letter to Representative Mary Helen Garcia. It was noted the rules and regulations committee will continue to study the issues.

It was moved by Mr. Cala, seconded by Mr. Forstbauer and unanimously,

VOTED: To respond that the Board is currently studying the issues noted in his letter and has not yet fully evaluated all the issues.

6. <u>OLD BUSINESS</u>

6.1 Presentation during April 10-11, 2003 NMPS Conference – Update – The Committee agreed that the session should be structured. Mr. Forstbauer will assign issues to the participating members, with attendees allowed time to ask questions. Ms. Garcia is to contact the President Elect to determine if the association will pay for the expenses, e.g. conference fee, room, etc.
