**16.39.8.6** – Objective: - Mr. Baumgartel strongly believes Fire Protection is a multi-disciplinary thinking and adds value to a project when defined as a specific discipline. He supports this addition of a definition for fire protection. Raymond Hensley speaks representing Hensley Engineering. As another member on the fire protection committee, he believes these new rules will protect the public and children in schools. As a representative of the NMSPE these new rules were

discussed and as a whole they supported these changes. Mr. Schoen thanks all the members who gave their time on the fire protection committee. Mr. Shah asks if letters relative to these rules change were distributed, and Mrs. Garcia responds the correspondence was mailed to the board members.

Mr. Sanchez asks for any discussion of the letters or additional testimony. Mr. Dourte asks when 16.39.2.8.D the four hours of ethics will go into effect. Mr. Sanchez explains the ethics will be required in the next renewal period. Ms. Himmelberger addresses the board as a professional engineer opposing the testing after two years rather than four as it is not testing the full four years of experience. Mr. Hensley explains the problem of testing and waiting 6 months to get the results has caused an extension into the fifth year before licensure.

Mr. Rosoff suggests the four-hour ethics requirements being changed to two hour for the single year. Mr. Schoen explains compliance goes by the end of the period that starts when the rule goes into effect. Mr. Rosoff then addresses the testing at two years covers engineering skills and not years of practice. Mr. Sanchez adds consideration was given to the fact that less is forgotten closer to graduation. Mr. Sisneros sees where getting graduate engineers into the system of licensure earlier will help them pursue it to the fouryear licensure. Mr. Sanchez recalls concern from the last NCEES meeting that the majority, possibly as high as 80%, of graduate engineers on the national level were not licensed. Mrs. Smith advises the ethics effective date can be separated out differently on the motion and as a motion and second are on the table all audience participation is inappropriate. Mr. Shah adds he was more in favor of volunteer ethics. Mr. Sanchez strongly supports mandatory ethics. A role call votes is taken and Mr. Guerrerortiz does not vote due to just arriving.

**VOTED:** approval, Mr. Romero, Mr. Sanchez, Mr. Vigil, Mr. Sisneros, Mr. Shah, Mr. Schoen, Mr. Atwell, unanimous

Motion by Mr. Shah that the ethics requirement be set for this year to 2 hours for 2006 renewals, second by Mr. Romero and unanimously,

**VOTED:** Motion approved

Mr. Sanchez directs staff to prepare final rules in appropriate form. Each adopted rule will supersede the current rule and will become effective 30 days after being filed with the state Records Center and Archives. Upon approval by State Records Center and Archives, the new rules will be published in the New Mexico Register as required by law. Copies of the new rules will be provided to all licensees and any person who submitted oral or written comments will be given notice of the actions of the Board if address information is available.
