Mr. Ytuarte explained that staff would like some clarification as to when the eighteen hours of education applies if an applicant by endorsement has a degree in a related science.

Ms. Bourassa stated that the situation would be, for example when an applicant has a related science degree such as civil engineering, and the applicant has attended an ABET accredited class and the applicant now wants to augment the required eighteen hours. Would the additional education be accepted?

Mr. Sanchez stated that if this is the case then it meets the standard rule, but what the committee keeps getting is the same person over and over who does not meet those requirements and they would like to stop seeing those come to them.
