1. Convene, Roll Call and Introduction of Audience

Mrs. Samora convened the meeting at 1:07p.m., roll call was taken and a quorum noted. Three individuals in attendance, Peter Nathanson, Angela Cross, and Aaron Ezzell.

5. <u>Public Comment/Correspondence</u>

a. Seals on Petroleum and Gas Pipelines

Mr. Valdez stated that Ms. Baca and himself received communication from a Licensee who works in the field of Petroleum and Gas lines. There are concerns from the Licensee that engineers are not signing or sealing design drawings for pipelines and this is a concern for the safety of the public. It was mentioned that other engineers who practice in the Petroleum and Gas field have said this is an Industry Standard. The Licensee is requesting the Board address this issue. Mr. Bohannan stated that there was a case against an individual, practicing without an Engineer License and how this has been placed on a radar list. He advised that there needs to be a Policy Advisory to look into what the Industry is doing, and that all drawings should be stamped. It was agreed by the Board that it was necessary to take a look at the Rules to get clarification.

b. P. Nathanson - Advisory on "As-built" drawings

Mr. Valdez stated he spoke with Mr. Nathanson and he requested to speak before the Engineering Committee on "As-built" drawings. The Committee did approve and adopt a Policy Advisory for Design Drawings, but has not posted it because it requires further reconsideration. Mr. Nathanson stated that he had a discussion with the Environmental Department and the City of Albuquerque regarding the requirements (that comply with the Advisory on "As-built)" drawings. The City of Albuquerque requires record plans to be filed 120 days after completion, these drawings need to be certified and credentialed with each project that is performed. This would enforce protection of safety and health to the public, this is not stated in State Regulation, but is petitioning the Board to make this a requirement or to ensure clarification on this topic.

a. Policy Advisory: Seals on Preliminary Conceptual Grading and Drainage Reports

City of Albuquerque are revamping their manual requiring stamps on preliminary drawings.
