**1. Convene, Roll Call and Introduction of Audience**

Mr. Gromatzky read the meeting script regarding the virtual meeting protocols. He convened the meeting at 9:11 a.m. Roll call was taken and a quorum was noted. Audience introductions made at this time.

Mr. Gromatzky requested that any audience members who may have any connection to any disciplinary cases recuse themselves from discussion in any said cases.

Mr. Valdez informed the Committee the meeting was noticed on the Board's website and at the Board Office.

Mr. Valdez informed the Committee that there was no public comment or correspondence received.

Ms. Woodward requested a status update of a disciplinary case on the agenda.

Mr. Gromatzky said after the closed session, the Committee will be able to provide a status update.

**6. Old Business**

**a. 2022 Datum Ellipsoid and State Plane Coordinates**

Mr. Gromatzky reported that until NGS publishes their coordinate system parameters, there is no action the PSC can do to define the coordinate system and the State Statutes. We will retain the definition for the NAD 83 coordinate system, because one change may greatly impact municipalities and others.

Mr. Aragon stated that NGS will not unveil the Datum change until late 2023 or early 2024. Mr. Gromatzky stated it was his understanding it would not be made public until that time. He said the actual state plane definitions, projections, should be available next month or two, or some later date.

**b. Survey Penalties Schedule**

Mr. Gromatzky said there was no update to the Survey Penalties Schedule.

## 7. New Business

### a. **NMSU Geomatics Program**

Mr. Valdez gave a presentation about the NMSU Geomatics program in regard to how many applicants passed the Fundamental Surveying (FS) exam and the Professional Surveying (PS) Exam from April 2021 to April 2023. He reported there were 12 individuals who passed the FS exam and 2 passed the PS exam.

Mr. Gromatzky presented data that showed the NMSU Geomatics program enrollment rate. He reported that the enrollment rate was increasing.

### b. **Updated Surveyor Application Form**

Ms. Gonzales presented the new application that will go into effect July 1, 2023.

Mr. Gromatzky asked if these changes were updated for the military applicants with the legislative law in regard to active-duty military.

Ms. Gonzales responded that the changes were included.

Mr. Gromatzky also asked if the application has also been updated to include the changes to the Practice Act recently signed by the Governor that allow for the new licensure paths.

Ms. Gonzales and Mr. Valdez said the changes were included.

### c. **Expedited Licensure Application Approval Process**

Mr. Valdez asked if the Committee would like to allow for him, as the Executive Director, to approve the applications which meet the requirements with the new changes. He would not approve those applications that are questionable and require board review and approval.

He explained that the PEC has allowed him to approve the engineering applications, who meet the requirements, in-house without going before the board.

Mr. Aragon stated that there would be two approval paths, one where the Executive Director approves the applications that meet the requirements and the other path where the Board approves the applications in question. Mr. Valdez responded that was correct.

Mr. Gromatzky said he would request that the applicants have a complete exam record along with the New Mexico 2-hour exam.

Mr. Gromatzky also said he would allow for the Executive Director to approve applicants and if Mr. Valdez were to vacate the Executive Director position, the approval privilege for the replacement Executive Director would be revoked.

He asked Mr. Valdez if a vote was needed for this item.

Mr. Valdez said a vote was not needed at this time and it could be voted on at the next meeting.

**d. NM Land Grant Committee Report**

Mr. Gromatzky informed the Committee that he and Mr. Valdez attended the New Mexico Land Grant Committee in Espanola, New Mexico on March 24, 2023.

He noted the Land Grant Committee brought up about the lack of surveyors and he responded that there is a scholarship opportunity to allow for more professional surveying opportunities.

Mr. Valdez noted the presentation went well and said that the Board Staff gave a presentation about licensing.

Mr. Valdez said that someone raised the idea for NMPS to provide a mentorship of students for surveying to allow for more people to become licensed surveyors in New Mexico.

Mr. Aragon mentioned that he attended a career fair in Espanola for one of the high schools. He said it was very beneficial for the students.
