1. Convene, Roll Call and Introduction of Audience

Mr. Maes read the meeting script regarding the hybrid meeting protocols. Mr. Ney convened the meeting at 1:05 p.m. Roll call was taken and a quorum was noted. Audience introductions made at this time.

Mr. Valdez informed the Committee there was no public comment or correspondence.

6. Old Business

a. Updated Engineer Application Form

Ms. Gonzales presented the updated engineer application form and explained the changes that were applied.

Mr. Tonander asked if the exam waiver was a separate form.

Ms. Gonzales informed the Board that the waiver form is added only to the exam and the EI/SI certification applications.

Ms. McNally asked Ms. Gonzales if the revision to include the reference to the Rules and Regulations will provide clarification for the structural component to applicants.

Ms. Gonzales informed the Board that this will provide better clarification since the requirements are listed on the first page.

Mr. Tonander suggested that a separate form be added to acknowledge that licensees have read our rules and proposed this could maybe be done with rule changes.

Dr. Elaksher asked about a PE State Specific examination to verify that licensee understands the rules.

Mr. Ney said this could be a subject for a future meeting.

Karen suggested those who have disciplinary action to take a PE State Specific examination for the rules.

b. Recommendations for the Fines and Penalties Table

Mr. Ney reported he went through the table and noticed there were violations with the maximum fine. He said the Board should note there is a range the Board can fine for each violation with a note indicating 'not to exceed'.

Mr. Tonander stated that he thought some fines were still low.

Mr. Ney said he will update the table and submit them to the staff and then have them reviewed at the August meeting.

Mr. Valdez said the AG's office stated that the Board should add that the fines and penalties table policy is a guideline.

Ms. McNally suggested under the section of 'Administrative failure to Report' separating the reporting of a criminal conviction portion from the change of address or employment section. She said the reporting of a criminal conviction is more serious than not reporting a change of address or employment. Mr. Ney agreed.

Mr. Tonander recommended for the failure to report criminal conviction to have a high maximum and higher minimum.
