1. Convene, Roll Call and Introduction of Audience

Mr. Aragon read the meeting script regarding the virtual meeting protocols. Mr. Aragon convened the meeting at 9:08 a.m. Roll call was taken, and a quorum was noted. Audience introductions were made at this time.

2. <u>Meeting Notification</u>

5. <u>Public Comment/Correspondence</u>

a. Gonzalez. M.

Mr. Gonzalez introduced himself to the Committee and provided a brief background of his qualifications for his SI Certification and PS examination application.

b. Burkholder, W.

Mr. Burkholder informed the Committee that he had attended the Geospatial Advisory Committee meeting on Tuesday, January 9, 2025. He stated that during the meeting there was a presentation from Keith Cole on the modernization of the national spatial reference system in regard to the state plane coordinate system. Mr. Burkholder recommended that the Committee review the recording.

6. Old Business

a. SPCS 2022 Update

Mr. Gromatzky stated that there is no new information and that they are just waiting for the definitions.

b. Right of Entry Flyer/Brochure

Mr. Valdez informed the Committee that the previous PSC had created a Right of Entry brochure. That the brochure was placed on the agenda for the Committee to review and if approved Board staff can print copies of the brochures and send them out.

Mr. Gromatzky asked if the brochure could be placed on the Board website and sent to NMPS instead of printing them. He proposed that the Board send the brochure by email to each licensee for them to print out.

7. <u>New Business</u>

a. Proposed Outreach – FFA and 4-H Youth Groups

Mr. Valdez stated that the Arizona Board and their society had reached out to the FFA and 4-H Youth Groups to promote surveying. He noted that the Arizona Board stated this has been a successful program and that the Committee and possibly NMPS should consider reaching out to New Mexico FFA and 4-H Youth Groups to promote surveying.

Mr. Aragon asked how the Committee would be able to get involved?

Mr. Valdez stated that we should first reach out to the organizations to let them know that the Committee is interested in promoting surveying to the organization. The Committee could attend their meetings or presentations. He noted that the organization have specific websites, and he could reach out to the chapters presidents to begin the discussion. Mr. Valdez asked Mr. Natera if NMPS would be interested in working in conjunction with the Committee to promote surveying.

Mr. Natera stated that he does think this is a good idea for NMPS.

Mr. Valdez stated that he will reach out to NMPS president Darly Costner.

b. PSC Sub-Committee for Review of Applications

Mr. Valdez placed this item for the Committees consideration to help streamline the process for approval of applications. He provided an example that when an application is complete, and the file could possibly have to wait three months before the application is reviewed at the next scheduled meeting. Board staff is proposing that the PSC create a sub-committee for review of applications.

Ms. Gonzales stated that what staff would do is scan in the application and send to two of the Committee members for review. The members of the subcommittee would review the application and either approve the application for the next step or the application will be placed on the agenda at the next scheduled meeting. The sub-committee could review the Recommended Approval, Inactive, Retired and Board Review applications. Mr. Wayne asked if staff will be asking for more detailed information on class syllabuses for those classes that may be questioned.

Ms. Gonzales stated that staff has started to ask the applicants for the class syllabus or do the research themselves.

Mr. Aragon stated that this is a really good idea because now the exams are offered all the time and not just April and October.

Mr. Aragon and Mr. Gromatzky stated that they would volunteer to be the reviewers.

Mr. Wayne stated that if the reviewers were busy then he could be the back-up reviewer.

Mr. Aragon stated that the applications will be sent to the two reviewers and if no response is received within 5 days, then it can be sent to Mr. Wayne.

She inquired if there was an interest for a New Mexico State Surveyor. Several states already have a state surveyor position.

Mr. Gromatzky said he provided a list outlining what a state surveyor might be responsible for and how it might benefit the public and interact with other state agencies. We could probably get the support from the Land Grant Committee and other agencies if this were explored more. There are several questions that need to be asked and answered regarding this position.
