However, he explained that the NCEES credential evaluation identified that he was deficient in biology or chemistry. Mr. Hojjati requested if the Board would reconsider his application, taking into consideration his years of experience and his degrees from the high-ranking college in England. Lastly, he noted that in the UK they do not have general studies, and everything is technical in the major you study.
