He requested the Committee to look at his experience after his bachelor's degree and his high school science classes.

**b. Patel, K. – PE Endorsement Application**

Ms. Patel introduced herself to the Committee and requested reconsideration of her PE endorsement application. She stated that she has 30 years of experience, and she does not meet NCEES standards and is deficient in biology or chemistry. She noted that she did take those classes in high school.

**c. Cortina, A.**

Mr. Cortina introduced himself to the Committee and provided a brief background on how he was approved by the Board previously to take the PE exam. He noted that he believed he mailed in all the required documents to allow himself to be eligible to sit for the PE exam.

Ms. Gonzales informed Mr. Cortina that the Board staff had emailed him in April requesting him to submit a new application. She requested Mr. Cortina to send his email address in the chat so Board staff can resend the email.
